#### **Berkane Regains Market Access to the United States**

**Report Highlights:**

Following the annual report, improved climatic conditions greatly improved Morocco's production and export outlook for MY 2017/18, Morocco's Berkane region regained market access to the United States, and Morocco updated its export subsidy program, albeit with only minor changes for citrus.

## Crop Update:

Citrus production for MY 2017/18 greatly benefited from improved climatic conditions following early season drought. Thus, Post adjusts the tangerine/mandarin forecast higher from 1.0 MMT to 1.2 MMT with exports raised from 420,000 MT to 520,000 MT. Meanwhile, orange production is increased from 0.9 MMT to 1.0 MMT with exports moved up from 100,000 MT to 160,000 MT. Changes in the orange balance sheet flowed through to orange juice. Post has no changes for the lemons/limes balance sheet.

### Policy Update:

On January 12, 2018, APHIS lifted the import prohibition on citrus produced in, moved through, or shipped from the Berkane region.

On May 3, 2018, Morocco published [Joint Order #3284-17](#) on agricultural export subsidies. Citrus support was unchanged following the expiration of time-limited subsidies directed toward Ukraine, China, and the Arab Gulf countries, September 1, 2014 - August 31, 2017.
